Parks Improvements & Programming: In 2012, OSA improved North Brooklyn's parks in a variety of ways. OSA employed two full-time maintenance staff who helped clean and maintain McCarren Park, Cooper Park, McGolrick Park and Java Street End Park. OSA installed restroom facilities at McCarren Park and Bushwick Inlet Park and planted entry gardens at the McCarren Track and McCarren's Gilroy Field. In addition to maintenance and beautification, OSA ensured lively parks by providing free programming in East River State Park, Sternberg Park, Transmitter Park, McCarren Park, McGolrick Park and Cooper Park. Programming included the Williamsburg Park concert series, free concerts in East River State Park, yoga, a reading series with Greenpoint's WORD Bookstore, tumbling classes with STREB, line dancing, skateboard classes and Shakespeare in the Park.

OSA Was Awarded the Contract for the Seasonal McCarren Pool Ice Rink: In 2012, OSA laid the groundwork to provide a seasonal winter ice skating rink for the North Brooklyn community. Slated for a fall 2013 opening, the 70' x 125' rink will extend the programming season of the McCarren Park Pool from 10 summer weeks to 16 - 20 weeks total per year.

OSA Volunteers: In 2012, OSA managed nearly 1,600 volunteers in North Brooklyn parks. These volunteers donated 4,600 hours of their personal time to beautify parks and open spaces in Greenpoint, Williamsburg and Bushwick. Volunteers were vital to the post-Sandy cleanup efforts. Nearly 300 volunteers cleaned up McCarren, McGolrick and Cooper Park in early November 2012.
